





# **Exhibitor FAQs**

## What does my booth include?

Each 10x10 booth includes pipe and drape, (1) 6' table with linen and table skirt, (2) chairs, (1) wastebasket and carpet.

### **Unloading/Loading/Exhibitor Floor:**

<u>Hall A overhead door</u> on Bryn Mawr Avenue (you can drive right in, unload, and then go park) 9291 Bryn Mawr Avenue, Rosemont, IL 60018

After unloading please park your vehicle across the street in the parking garage.

## Where do I park after unloading?

- The Parking Garage is located directly across the street from the Convention Center
- There is a BIG overhead street sign directing you where to turn for the *Convention Center Parking Garage*
- You will receive a parking ticket upon entrance
  - Parking is \$15
  - When leaving after the event you will find kiosks to pay
- There is a SKYWALK from the parking garage to the convention center
  - Follow the GCCMA EXPO Signs to the Convention Center
  - Allow 10-15 minutes to park and walk over through the warm skywalk

#### Will WiFi be available?

Yes! WiFi is available through Boingo, it does need to be "reset" every 4 hours. You can order hard-wire internet if needed through RES (see exhibitor kit).

#### What if I forget to order something for my booth?

There is a RES Service Center located right in the exhibit hall. Someone will be there throughout the show (move in and move out as well) to answer any questions, and order additional booth items. The rates are higher, so it is suggested to order early!

## Are Exhibitors Required to Wear Show Floor Credentials?

Yes! All exhibitors are required to wear a name badge. Names for attendees are entered at registration and/or emailed to kathy@gccma.org by January 24.
